

Terms and Conditions

Relating allocation, administration, and cancellation of Domain Names in the area .fo on the Internet.

Effective as of April 2nd 2022

The private foundation *FO-ráðið* has formulated this regulation and *FO-ráðið* is responsible of the maintenance of the area .fo on the Internet. Equally, *FO-ráðið* is entitled to modify the regulation.

1: The right to use .fo Domain Name

In order to have the right to use the Domain Name, it is obligatory to create a user digitally on www.økisnavn.fo. The user must, among other things, also account for name and credit card information, which will be used when paying for the service. In conformity with *FO-ráðið* the cardholder is the same as the user.

The purchase is complete as soon as the user has paid for the right to use the Domain Name. This means, that if no one else has bought the right to use the Domain Name, the user has the right to use the Domain Name as soon as the purchase is finalized. *FO-ráðið* does not look into the matter if the Domain Name violates the rights of a third party in relation to its name- and trademark.

The right to use the .fo Domain Name is active as long as the user is paying for the right.

2: Public provisions regarding Domain Names

The Domain Name may include letters that are used in the Faroese and English alphabet, numbers, hyphens (-), however, a hyphen cannot be used as the first or last sign. The Domain Name may only use numbers. The Domain Name must not exceed 63 letters (including fo).

3: Responsibility

Even if the user has been given the right to use the Domain Name in accordance to this regulation, the user may not have the right to use the name in another context. The protest from a third party against the usage of a Domain Name should always be directed to the user, who has paid for and owns the right to use the Domain Name.

FO-ráðið cannot be held responsible for the user's usage of the Domain Name or the content on a potential website.

The user has the responsibility to make sure that registration of the Domain Name does not go against the regulations of the Faroese legislation or the right of a third party.

The right to use the Domain Name is transferable. Still, all sale and transfer must be registered on www.økisnavn.fo, this procedure gives insight into who pays for the Domain Name.

It is the user's responsibility to make sure that the information in the system is correct as well as updating any alterations.

4: Cancellation of a Domain Name

A Domain Name can be cancelled through the userportal on www.økisnavn.fo

The user does not have the right to receive compensation for remaining time that is already paid for. The relevant Domain Name will subsequently be taken out of the registration and be available for others to register.

Domain Names cannot be put aside.

5: Warning and deletion

The user will get a message via e-mail if the payment for a .fo domain name is not received in time. The user will be given 40 days to get the payments affairs in order.

If the user does not respond within 40 days after receiving a warning, the Domain Name will be deleted and the user loses the right to use the Domain Name.

FO-ráðið can delete a Domain Name without further notice if the judicial decision is available in this relation.

6: Payments.

An annual subscription will be paid for in connection with the purchase of the right to get a Domain Name. The payment will be paid when the Domain Name is registered and the annual subscription will be paid beforehand for the upcoming period. The annual subscription is currently kr. 280,- + VAT, or the total amount kr. 350,- including VAT.

The annual subscription will automatically be withdrawn from the credit card when the transaction is scheduled.

FO-ráðið may modify the annual subscription. These changes will be posted on the webpage www.økisnavn.fo.

7: Regulation

The user must confirm that he/she has read and accepted this regulation before creating a digital profile on www.økisnavn.fo.
